

Job development and increase in national hourly wage(s): I advocate for the development of an economic framework that fosters prosperity and inclusivity for all members of society, rather than exclusively benefiting a select few. This necessitates the creation of high-quality employment opportunities that offer competitive wages, thereby ensuring financial stability for individuals and households. This initiative commences with a strategic investment in the American populace and their prospective endeavors. This necessitates the augmentation or generation of novel employment opportunities across the sectors of infrastructure, manufacturing, technology, and sustainable renewable energy, concurrently fostering and facilitating prospects within small, private businesses for substantial growth and expansion opportunities.

○ **Manufacture Losses:**

- From January to September 2025, the United States observed a reduction of approximately 49,000 manufacturing positions. This decrease is partially attributed to the tariff policies implemented by the Trump/JD Vance administration.

○ **Federal Workforce Reductions:**

- Federal employment decreased by 277,000 from its January peak by December 2025, primarily due to an increase in resignations.

○ **Significant Layoffs and discharges:**

- From January to August 2025, there were 13.8 million instances of "Layoffs and discharges," which encompasses temporary separations and does not exclusively indicate permanent offshoring.

○ **AI Impact:**

- Approximately 54,694 job reductions in 2025 were attributed to the implementation of artificial intelligence.

○ **Tech Sector:**

- By late 2025, technology sector layoff announcements reached a total of 141,159, with approximately 70% originating from U.S.-headquartered companies.

○ **Retail sector:**

- The sector experienced more than 91,000 announced layoffs in 2025, representing a 139% increase compared to 2024.

○ **Overall facts and overview:**

- Although job creation occurred, the rate of growth experienced a significant deceleration in 2025, with the total estimated job growth for the year reaching 584,000, representing the lowest figure since 2009.
- U.S. Employers have announced over 1.1 million job reductions extending through October 2025, marking the highest level of layoffs observed since the 2020 COVID-19 pandemic.
- In 2024, the American economy experienced a total job growth of 2 million positions, representing a substantial increase compared to the 584,000 jobs added in 2025.
- Following a peak in January 2025, federal government employment experienced a reduction of 277,000 positions, representing a 9.2% decrease by year-end 2025.

My objective is to address the outflow of employment opportunities from the United States. I am dedicated to collaborating, communicating, and negotiating with corporate leaders to preserve our business relationships. This entails a commitment to evaluating tax percentages while simultaneously identifying areas for regulatory reform that could stimulate job growth and foster the expansion of businesses, both large and small, ultimately encouraging their continued presence within the country. In addition, I am committed to address American trade interests with other agencies, companies and countries. The U.S. Makes up 4.2 to 4.5 percent of the world's population, leaving roughly 95% of the rest of the world's population that the U.S needs to have positive open dialogue, working relations and trade networking partnerships.

As President, my administration and I are committed to evaluating the potential for implementing an equitable and transparent incentive tax system. This system would aim to appropriately reward contributions while simultaneously addressing national priorities, fostering economic growth, and facilitating investments in employment and the educational and skill development of the American populace.

My proposal outlines a policy wherein companies opting to relocate their operations internationally, while continuing to supply goods to the American market, will incur a proportional tax on all merchandise imported into the United States. It is imperative to recall the economic landscape of the Great Recession, from 2007 to 2009, a period significantly influenced by fiscal policies that reduced taxation for high-income earners and neglected investments in the middle class. These factors collectively contributed to a severe economic downturn, resulting in the loss of 8.8 million jobs between 2007 and 2009.

Additionally, approximately 10 million individuals lost their homes, and 6 million households experienced foreclosure as a result of the Great Recession and the subsequent housing crisis, with the majority of this displacement occurring between 2006 and 2014. Furthermore, an estimated 11 to 17 trillion dollars in family wealth was eradicated. While significant progress has been made since that period, it is imperative that we avoid reverting to the policies that initially proved detrimental. Consequently, my administration is committed to exploring advantageous options that serve the interests of all Americans when addressing critical issues such as wages, inflation, job losses, and the overall American economy.

It is imperative that we engage in comprehensive deliberation, active listening, and public participation, while simultaneously collaborating with expert professionals whom the government can utilize in making critical decisions. These decisions possess the potential to stimulate significant growth and opportunities, thereby averting catastrophic outcomes and severe consequences that could result in an escalated national deficit or another national financial crisis. In evaluating all options pertaining to employment, compensation, and trade, I will apply a consistent standard to each.

The U.S. national debt experienced a substantial increase, escalating from approximately \$26.9 trillion in 2020 to exceeding \$38 trillion by late 2025 or early 2026. This surge was primarily driven by expenditures related to the pandemic, elevated interest rates, and persistent deficits, resulting in a significant rise in the debt-to-GDP ratio. Nevertheless, a modest decline from its 2020 peak is projected, reaching approximately 98-124% by 2024/2025. This rapid expansion has led to interest payments becoming a prominent federal expenditure, nearly tripling since 2020 and surpassing defense spending in Fiscal Year 2024. As President, my objective is to articulate precise strategies for economic advancement, focusing on sustainable growth without escalating the national debt.

how does the national debt work

The national debt is the total amount of money the federal government has borrowed to cover the gap between what it spends and what it receives in revenue (the budget deficit). As of early 2026, the U.S. national debt stands at approximately **\$38 trillion**.

1. How the Government Borrows

When the government runs a budget deficit, the U.S. Treasury borrows money by selling **securities** to the public and other entities.

- **Treasury Securities:** These include Treasury bills (short-term), notes (2–10 years), and bonds (20–30 years). They are essentially "IOUs" where the government promises to pay back the principal with interest over a set period.
- **Safety Factor:** U.S. Treasuries are widely considered one of the world's safest investments because the government has never defaulted on its payments.

2. Who Holds the Debt?

The debt is categorized into two main groups:

- **Debt Held by the Public (~\$30.5 trillion):** Held by individuals, corporations, the Federal Reserve, and foreign governments (such as Japan, the UK, and China).
- **Intragovernmental Debt (~\$7.5 trillion):** Money the government owes to itself. For example, when the Social Security program has a surplus, it invests that money in Treasury securities, which the government then uses for other spending.

3. Key Concepts

- **Debt Ceiling:** A legal limit set by Congress on how much the Treasury can borrow. Reaching this limit does not authorize new spending but allows the government to pay for bills it has already incurred.
- **Debt-to-GDP Ratio:** Economists often measure debt relative to the country's Gross Domestic Product (GDP). In 2026, the U.S. debt-to-GDP ratio is approximately **124%**, meaning the debt is larger than the nation's total annual economic output.
- **Interest Payments:** The government must pay interest on its debt. As of 2026, annual net interest costs are projected to reach or exceed **\$1 trillion**, making it one of the fastest-growing parts of the federal budget.

4. Why Does It Matter?

While the government can theoretically carry debt indefinitely as long as it can make interest payments, high debt levels can lead to:

- **Crowding Out:** High government borrowing can compete with private investment, potentially slowing long-term economic growth.
- **Interest Pressure:** As debt and interest rates rise, more tax revenue must go toward interest payments instead of public programs like education or infrastructure.
- **Crisis Risk:** If investors lose confidence in the government's ability to pay, they may demand higher interest rates, creating a cycle of increasing debt costs.

To address these financial discrepancies, my administration and I will identify areas for expenditure reduction, concurrently exploring strategic investments to optimize the American economy, its workforce, and resources, without significantly increasing the U.S. National Debt.

My administration intends to collaborate with federal, state, and local entities in a bipartisan initiative to elevate the minimum wage for American citizens. The national minimum wage has remained at \$7.25 per hour since 2009. Nevertheless, numerous states and local jurisdictions frequently establish their own minimum wage mandates for employers, which typically surpass the federally stipulated hourly rate. For states such as

- Louisiana : \$7.25 - Federal Law Minimum Wage is enforced
- Mississippi: \$7.25 - Federal Law Minimum Wage is enforced
- South Carolina: \$7.25 - Federal Law Minimum Wage is enforced
- Tennessee: \$7.25 - Federal law minimum wage is enforced
- Georgia: \$5.15 - State law minimum wage, however national federal minimum wage is enforced
- Wyoming: \$5.15 - State law minimum wage, however national federal minimum wage is enforced

As President, my objective is to elevate the federal national minimum wage to a range of \$18.00 to \$20.00 per hour for full-time employees and \$16.50-\$18.00 per hour for part-time/per diem employees across all enterprises operating within the United States and its territories. This initiative is driven by the imperative to address the impact of inflation on the cost of living and the accessibility and affordability of housing. Furthermore, my administration will endeavor to ensure equal pay and opportunities for women in the workforce nationwide. Additionally, as President, I will advocate for companies to implement profit-sharing programs, asserting that all individuals who contribute to the generation of profits, in any capacity, should be entitled to a share, not solely senior-level personnel or executives.

Furthermore, as president, I am dedicated to evaluating and examining the existing programs, benefits, and policies designed to support families striving to balance professional and personal responsibilities. Life often presents unforeseen challenges beyond our control. I have personally witnessed instances where individuals or family members are compelled to choose between their employment and their families, leading to instability, uncertainty, and significant stress for many Americans. Single parents frequently encounter such dilemmas. Therefore, my administration will endeavor to address, investigate, and facilitate necessary modifications to enhance flexibility in family leave, earned sick leave, childcare programs, daycare services, and educational support initiatives.

America's direction with law enforcement conduct, accountability, law and order, and Restitution:

As President, my administration is committed to upholding and promoting law and order nationwide. We will hold all federal law enforcement agents, officials, and personnel under my administration's direction accountable for ensuring that lawlessness and chaos are replaced with a steadfast commitment to legal and orderly conduct. In 2025 under the Trump/JD Vance administration, Federal Agents were given the approval by federal leadership individuals to unconditionally, illegally, and racially profile Americans.

As president, I will pursue congressional approval to enact new legislation addressing constitutional obligations arising from court rulings. Furthermore, I will endeavor to commence the constitutional amendment process to supersede the court's interpretation of unlawful judgments, such as (*Vasquez Vs. Nunez*) which gave I.C.E approval to racially profile Americans based on race, color of their skin, how they sound, and where they work. The 4th amendment nationally protects Americans from such disdainful acts of behavior.

During my term(s), I intend to appoint several special prosecutors, while using the Attorney General, and the FBI director. to collaborate with the Department of Homeland Security secretary, as well as local and state law enforcement agencies, officials, and the public. This initiative aims to facilitate the apprehension of any federal law enforcement agent found to have infringed upon American citizens' civil and constitutional rights or to have breached their oath to uphold the Constitution. This policy will extend to individuals who are currently or were previously employed with DHS, effective from 2024 until my departure from the presidency.

This administration will give you the same option as previous administrations have: you'll have the ability to turn yourself in, or we will apprehend you. Furthermore, this administration's actions will elevate national awareness among all law enforcement agencies, agents, and officers, demonstrating accountability through tangible measures. This initiative underscores that officers and agents at every governmental level are not exempt from legal statutes and are subject to the same standards as any other individual within the United States who violates the law.

Furthermore, as president, I am committed to collaborating with the Secretary of Homeland Security to implement lawful and effective training programs for ICE agents and Border Patrol agents, while also sharing new training standards with the general public to ensure transparency. The re-establishment of law and order, coupled with a mutual respect between law enforcement and community residents, represents a significant priority for me. It is imperative that we re-cultivate open, secure, and respectful communication channels. This endeavor will simultaneously foster stronger relationships between the community and law enforcement. The objective of safeguarding American citizens while achieving effective outcomes is attainable, provided both parties demonstrate a commitment to collaboration and mutual respect.

Finally, as president, I will collaborate with my administration to explore avenues through which the federal government can demonstrate accountability to the American populace for any unethical, illegal, or unconstitutional actions against the public. I wish to reiterate the essential role of our law enforcement agencies, officers and agents including ICE. Nevertheless, It is paramount that all law enforcement personnel, upon deployment, uphold their oath, adhere to legal statutes, and maintain a sense of law and order that aligns with the United States Constitution. Concurrently, it is equally crucial for all American citizens to ensure their conduct is in accordance with the law while following lawful orders from law enforcement.

As President, my administration and I will assess the necessity of increased funding for local and state law enforcement agencies. This funding will be allocated to facilitate comprehensive training programs in areas such as domestic mental health, physical use-of-force techniques, and advancements in technology and weaponry. These enhanced measures will assist law enforcement in addressing the use of military-style weaponry and navigating complex and heightened community domestic physical and mental health concerns. Unrestricted Training measures will be shared with community residents, to ensure accountability and transparency.

Should an officer or agent of the law unlawfully detain you or issue an unlawful or unconstitutional order, it is advisable to remain composed, comply with directives, and, if feasible, record or videotape the interaction. Officers and agents are expected to have their body cameras activated and recording at all times. You may consider submitting a FOIL request to your local government and consulting legal counsel to pursue accountability or justice for any wrongful actions committed against you during your detention or arrest.

America's direction with crime and Race: Racial disparities continue to present significant challenges, disproportionately impacting various aspects of life, including housing, education, and justice accountability. Globally, we observe pervasive evidence of biased practices. Therefore, my administration and I aim to address this issue directly. My administration will focus on the restoration of trust between law enforcement and the communities they serve.

I propose the establishment of a specialized national police task force designed to collaborate with both the public and law enforcement agencies. This initiative aims to foster a deeper understanding of the challenges and concerns faced by all parties, ultimately facilitating the development of effective solutions to re-establish clear communication, uphold law and order, and cultivate mutual trust and respect. Furthermore, I will evaluate the potential need for increased financial support for local and state law enforcement agencies. This funding would be strategically allocated to enhance comprehensive training programs, specifically in areas such as domestic mental health, appropriate physical use-of-force techniques, and advancements in technology and weaponry. These enhanced measures are intended to equip law enforcement with the necessary tools to address the proliferation of military-style weaponry and to navigate complex and escalating community concerns related to domestic physical and mental health. To ensure accountability and transparency, unrestricted training protocols will be shared with community residents.

The gun epidemic is the leading cause of death for young African American men, more than the next nine causes combined. Therefore, effective and strategic implementations must be set to mitigate such incidents. Most of the fatal incidents can be prevented if common respect, compliance, law, and order are established across the board.

- **Deadliest year (2024):** Monitoring groups identified 2024 as the deadliest year on record for police violence, with at least 1,365 people killed by law enforcement.
- **2025 Data:** Preliminary reports for 2025 indicate at least 1,201 people were killed by police, which is a slight decline from 2024, but still higher than pre-pandemic levels.
- **Disproportionate Representation:** While African Americans account for roughly 13-14% of the U.S. population, they frequently account for 25-27% of fatal police encounters.
- **Emerging Adults:** Black men between the ages of 20 and 24 are killed at more than triple the rate of white men in the same age group.

Sentencing racial issues also need to be addressed, To many african and latino Americans end up in jail or prison for nonviolent crime offenses. It is an unfortunate reality that young African American and Latino American individuals are disproportionately impacted by the criminal justice system, facing higher rates of arrest, charges, convictions, and incarceration compared to Caucasian American men who commit similar offenses. The presence of systemic racism within our criminal justice system demands immediate and comprehensive action. Therefore, my administration will establish a specialized national police task force. This task force will be dedicated to fostering collaboration between the public and law enforcement agencies, with the aim of understanding the needs of both communities and law enforcement. Concurrently, that team will collectively develop and implement a proposed "second chance" program and comprehensive re-socialization services recommendations, specifically designed for non-violent and formerly incarcerated individuals.

As President, my administration is committed to pursuing the elimination of privately operated correctional facilities within the United States. The incarceration of American citizens should not be influenced by profit-driven motives. My administration is committed to addressing these challenges directly through proactive measures, tangible outcomes, and systemic reform, alongside fostering robust community engagement. Additionally, the implementation of pragmatic firearm safety regulations is imperative. The use of military-grade weaponry among dangerous individuals, coupled with their readily available access, presents a significant security risk.

In many cases law enforcement lacks the appreciated weaponry to effectively counter these weapons, placing both law enforcement and the community at risk. Therefore, my administration and I will push for the implementation of increased comprehensive and universal background checks to help identify a person's history prior to purchasing a gun. My administration and I do not oppose Americans owning firearms, however, if you pose a safety risk to yourself or others, over the past 5 years at the time of occurring a firearm. My administration and I will seek to work with congress to pass a law where Americans are required to be evaluated by a medical physician and mental health psychiatrist, identifying your suitability and stability mentally and or physical period before obtaining an approval to carry or possess a firearm.

Additionally, my administration and I will work with Congress to pass new laws, requiring a new age of 25 or older for individuals to purchase a semi automatic weapon This is when the gun's action automatically loads the next cartridge after each shot, also known as self-loading. This means the gun self-loads or autoloads each cartridge without manual bolt/pump action between shots, allowing quick, repeating shots without pause until the cartridge is empty. Such Gun(s) include:

- **Glocks , AR-15s/M4s, and AK-47s**
- **Ruger 10/22s**
- **Springfield Hellcats**
- **S&W, M&Ps**
- **Beretta APX**
- **Cross Pistols**
- **Rifles such as AR-15,MA,AK Platform**
- **Shotguns such as the Remington 1100.**

Exceptions: Shotguns, such as the Remington 1100, may be utilized for hunting or sporting events under the direct supervision of an individual aged 25 or older, or the organizing agency of the event, provided the individual has been approved to possess such a weapon for these purposes. An exception to this age requirement may be granted for law enforcement personnel under the age of 25, specifically when the use of any aforementioned

weapon is mandated for their official duties, and this exception applies solely during their active service. Based on statistical data indicating full brain development at approximately 25 years of age, my administration will propose that access to Semi-weaponry be restricted for all individuals under the age of 25, irrespective of gender, unless they satisfy the previously outlined exceptions. For individuals aged 18 to 24, possession of the proposed non-semi weapons may be permissible under specific, pre-defined conditions.

- **Revalvers** - These devices employ a rotating cylinder to align cartridges with the barrel and typically do not feature automatic casing ejection or reloading mechanisms.
- **Bolt-Action Rifles/Shotgun(s)**: The user manually operates a bolt handle to eject the shell and chamber the next one.
- **Lever -Action Rifles/Shotguns**: The action is cycled by means of a lever situated near the trigger guard.
- **Pump-Action/Shotguns/Rifle(s)**: The user cycles the action by sliding the forend back and forth.
- **Break-Action/Single-shot Firearm(s)** These must be opened, manually unloaded, and relocated after every single shot.
- **Muzzleloader(s)**: Firearms that are loaded through the muzzle.
- **Non-Semi -Automatic AR -15**: specialty rifles designed to function as repeaters, often requiring the user to manually release the bolt or action after each shot to comply with specific state regulations

Parental Overview: for when a child or someone under the age 18, may possess a bow and arrow and/or BB gun(s)

- **Bow and Arrow** - This process necessitates the manual nocking of each arrow onto the bowstring, followed by drawing and releasing the string.
- **BB Gun(s)** - These devices are pneumatic or gas-powered air guns that utilize compressed air, CO2, or mechanical springs to propel small metal or plastic projectiles.

I understand that the proposed arrangement may not be universally favored. However, I invite you to consider the following perspective: if an individual between the ages of 18 and 24 chooses to introduce a weapon into an educational institution, business, or public environment, with the intent to kill, Possessing a non-semi-automatic weapon allows milliseconds more for potential victims to find shelter and flee with fewer casualties. because the gunman will need to stop, reload, and aim, versus an automatic weapon that does not require a gunman to do this. Furthermore, it presents an opportunity for law enforcement to manage the situation. When they do not have rapid gun shots firing at them. Lastly, as previously articulated, I do not oppose the right of Americans to possess firearms; rather, I aim to ensure their capacity for self-defense in critical situations. As President, I bear the responsibility for the safety and well-being of all American citizens. Therefore, implementing safeguards for both personal and public safety within homes and communities is imperative. Every preventable loss of life is one too many, and it is crucial that we learn from successful strategies and avoid ineffective approaches.

Veteran Accountability and resources:

As a veteran with six years of service in the United States military reserves, I emphasize the critical importance of ensuring that our fellow veterans receive timely access to beneficial and effective services and resources upon their transition from military service. This encompasses access to healthcare, housing, workforce development, comprehensive compensation benefits, and reintegration services. It is frequently observed that many veterans depart service with an insufficient understanding of their entitlements and the available services and resources.

As president, I will appoint and work with the new Veteran Affairs Secretary, to ensure the navigation of services and resources both within and out of the VA is easily accessible and comprehensible. Some Veterans have mentioned they do not feel the VA is actively doing a good job representing their needs, and or offering comprehensive effective services that allows the veteran to truly reconnect with their community.

For the fiscal year 2026, the proposed budget of \$441.3 billion, which includes significant increases for compensation, pensions, and the Toxic Exposures Fund (TEF), is currently under consideration. As president, I commit to maintaining the \$441.3 billion request for the 2026 fiscal year for and through the years of 2033-2037 and will instead focus on actively ensuring these funds are strategically allocated to the various offices, programs, and services offered by the Department of Veterans Affairs appropriately. Furthermore, I will collaborate with the Department of Veterans Affairs and all other pertinent Federal Departments to ensure the prevention of fraudulent expenditures and to prioritize the implementation of maximum cost-saving measures while upholding the highest standards of service, care and opportunity.

Healthcare reformation and improvement:

Healthcare coverage represents a significant concern for many American citizens. As president, I am dedicated to collaborating with insurance providers and experienced insurance professionals to develop a comprehensive, universal United Healthcare plan. This initiative would position the federal government as the central intermediary for compensation reimbursement to hospitals, medical providers, and various forms of social, mental, and physical healthcare services. Furthermore, my administration would guarantee coverage irrespective of an individual's citizenship status or financial capacity to afford treatment, in accordance with the Emergency Medical Treatment and Labor Act (EMTALA) of 1986.

NATO/E.U and international networking reconciliation:

Globally, the United States has experienced a decline in credibility, particularly amidst discussions regarding the potential discontinuation of the NATO alliance. This is largely attributable to the concerning actions of the Trump and JD Vance administration because of forcefully trying to obtain another NATO territory through tariffs or military action. Moreover, the U.S government through its consistent bullish actions, has threatened other democratic states' leaderships with invasion through military action if specific actions are not improved or met by the Trump/JD Vance administration. This has resulted in significant disruptions to diplomatic relations with esteemed state leaderships, shifts in strategic alliances, and a detrimental portrayal of the United States government and its military administration.

As President, I will appoint a new Secretary of State to collaborate closely with European nations and key international organizations, including the E.U., NATO, and the U.N., to re-establish robust United States relations. Additionally, I will direct the Secretary to facilitate restoration aid for Ukraine, contingent upon the cessation of hostilities by the commencement of my term. Should the conflict persist, I will mandate the Department of State Secretary to secure a ceasefire resolution within 90 days of assuming office. This individual will then be granted an additional 90 days to broker a peace treaty agreement to conclude the war.

Housing Accountability and Affordability:

Based on data from the *U.S. Bureau Of Labor Statistics (BLS)*: In 2025, young men aged 16 to 24 who are employed full-time are projected to earn a median weekly income ranging from approximately \$802 to \$825, while young women in the same demographic and employment status are expected to earn a median weekly income between \$593 and \$752.

In 2025, the median annual income for a four-person family unit was approximately \$139,900. The average annual income for a four-person family was higher, at around \$178,500, influenced by high earners. For context, the national median household income across all household sizes in 2024 was approximately \$83,730 annually, which is considered a more accurate representation of typical earnings than the average of \$121,000. It is important to acknowledge that these figures are significantly impacted by an individual's location, personal financial obligations, and spending habits.

As President, I am dedicated to collaborating with the American populace, as well as local, state, and federal entities, to enhance our approach to housing affordability and accessibility. We firmly believe that housing is a fundamental right, not a luxury, and every individual deserves the opportunity to rent or acquire a home that provides security, privacy, and financial feasibility. My administration will partner with Progressive Insurance on their "Open the House" initiatives, which provide financial assistance through their down payment program to first-generation homebuyers.

DHS Border Patrol on going efforts:

My administration is committed to ensuring the safety of American citizens through robust border security measures. I intend to evaluate the operational requirements of border patrol by engaging in discussions with agents and the Department of Homeland Security. This process will encompass considerations for budgetary allocations, technological advancements, and the implementation of humane, constitutional, and legally compliant deportation procedures for criminal, violent and undocumented individuals within the United States.

Our administration is prepared to address the concerns of individuals who have resided in the United States without documentation for five years or more, maintained a clean criminal, nonviolent record, fulfilled tax obligations, and demonstrably contributed to society and or have children. We understand the need for accountability for not following the law, thus those who meet the qualifications as listed above will be allowed to stay in the U.S. however, will need to pay a civil fine of 500.00 and or spend 6 months to 1 year in county jail.

Following the successful completion of your incarceration period and/or the remittance of your civil penalty fee amounting to \$500.00, you are eligible to initiate the citizenship application process. Your prior incarceration will not be deemed a disqualifying factor, provided it did not involve acts of violence or the commission of additional offenses during that timeframe. Furthermore, should you engage in criminal activity or acts of violence subsequent to your incarceration and/or civil payment, you will be apprehended, detained, arrested, and afforded due process. Depending on the outcome of your conviction, you may be subject to deportation.

Should you have dependents, they will be presented with the option to accompany you during your deportation. Alternatively, if a legal guardian is designated as an emergency contact, they may be contacted to retrieve your child from social services. In the absence of an emergency contact or legal guardian for the child, you will be required to take your child with you upon deportation. A last-minute petition for reconsideration may be filed based on concerns for your personal safety or that of your child, should deportation occur. However, if the State Department approves your request, you will serve your conviction sentence, and your children will be placed in social services where representatives will endeavor to maintain your relationship with your child while they are in temporary foster care, distinct from your release

You have the option to reapply for a visa, green card, or full U.S. citizenship during your period of incarceration. Should your application be approved, you will not face apprehension upon the completion of your sentence. Instead, social services will continue their close collaboration to address your immediate fundamental needs and facilitate your reunification with your child. Furthermore, a representative from the State Department will conduct a follow-up after your incarceration to ensure your understanding and affirmation of all U.S. laws and approved application requirements for legal residency in the U.S.

Finally, I aim to collaborate with DHS leadership to implement updated training protocols that yield resolute yet effective outcomes, potentially enhancing the performance of Border Patrol agents. This

initiative will concurrently focus on refining policies to benefit American interests, ensure agent safety, and uphold the human rights of detainees.

Foster Care Services:

Foster care, when implemented with responsibility, accountability, and an empathetic, safe approach, can offer crucial care and support. Given that many children entering the foster care system have experienced trauma, my administration will prioritize identifying areas for improvement in safety protocols, technological advancements, and policy frameworks to mitigate further potential traumatic experiences. My administration is dedicated to upholding parental rights and facilitating the reunification of children with their parents, contingent upon the establishment of a safe and secure environment. Consequently, it is essential that all avenues for parental support and intervention are comprehensively explored prior to considering adoption as an alternative.

I hold our agricultural industries and the farmers who supply goods to the American populace in high regard. Thus, I am dedicated to collaborating with our farmers to gain a deeper understanding of their daily requirements, thereby enhancing their capacity to continue providing their products to the American public and border. Several farmers have expressed the following concerns:

1. High production costs: Expenditures related to fertilizer, fuel, and machinery continue to be elevated, thereby impacting profit margins.
2. Falling commodity prices: Following their 2022 peaks, the prices of corn, soybeans, and other agricultural commodities experienced a substantial decline, primarily attributable to an increase in global supply, partly originating from South America, and a decrease in export demand.
3. Trade Wars & Tariffs: Previous trade disagreements have adversely impacted long-standing relationships with key purchasers such as China, thereby diminishing the perceived reliability of U.S. agricultural products and influencing export markets.
4. High Debt: Farmers are experiencing elevated levels of debt, intensified by high interest rates and diminished incomes, which subsequently impedes their ability to secure loans for the upcoming planting season.
5. Unfavorable Market Conditions: A global surplus in grain production and heightened market competition have driven down the price of flour, necessitating that farmers achieve greater yields and reduce operational expenses merely to reach profitability.
6. Economic Crisis in Rural America: Net farm income has experienced a significant decline since 2022, with numerous forecasts indicating impending losses, thereby raising concerns regarding food security and the sustainability of family-owned agricultural enterprises.

My administration and agricultural stakeholders will collaborate to enhance the future viability of our farmers and ensure their continued stability in producing goods both domestically and internationally.

Home Domestic Attacks:

My administration is committed to a collaborative approach, engaging with both Democratic and Republican representatives to address the issue of domestic attacks within our nation. Furthermore, we will establish comprehensive networking relationships with technology, social media, and other national and multinational companies to enhance security measures, thereby safeguarding American consumers from potential acts of violence, exoneration, sexual underage predatory behavior and cyber criminal activity.

To achieve this, my administration will collaborate with Congress and other federal government counterparts to enact legislation that enhances accountability and responsibility within the following areas.

- **Intelligence and information sharing:** Our objective is to enhance threat analysis and facilitate intelligence sharing among federal, state, and local law enforcement agencies. This initiative aims to mitigate the proliferation of extreme violence and ideology, sever terrorist affiliations, and counter international state actors who seek to compromise protected American information across business, private, and public sectors.

Individuals under the age of 18 who fail this verification process when attempting to access such websites may trigger interventions from law enforcement, early mental health prevention programs, or other community support mechanisms. These measures aim to mitigate potential developmental, criminal, or inappropriate social behavioral concerns. Parents and/or legal guardians will retain full discretion regarding the actions they choose to pursue when such concerns emerge and in selecting the resources offered to their families.
- **Threat Assessment and Training:** Enhancements in the identification of potential threats and the training of law enforcement personnel to recognize indicators of such threats will be incorporated into updated training programs for all local, state, and federal law enforcement agencies.

Nuclear Weaponry and Military Accountability:

Modernization of our national defense systems, encompassing nuclear capabilities and military assets, is imperative. Concurrently, our capacity to serve as a global stabilizing force is constrained by extensive international commitments, many of which lack appropriate reciprocation. This overextension diverts critical resources, as governmental investments are allocated to foreign conflicts and interventions designed to uphold global values and freedoms, thereby impacting essential domestic investments in national security, stability, and economic prosperity.

My administration and I will work with the department of defense Leadership in ensuring weaponry and nuclear capacity resources are updated. Moreover, I will work with the security and leadership of the Department of Defense to ensure common sense policies and programs are actively providing and creating opportunity for our active military personnel. Our military are our protectors, and hold great value to the United States and the world. I want to make sure their needs, pay, benefits and overall growth reflect how grateful we are to them.

I have given extensive consideration to this topic. When contemplating education, I envision it as a cornerstone for future opportunities. This necessitates a significant investment in our children, young adults, and individuals pursuing vocational skills. My administration will prioritize comprehensive environmental safety measures and enhance the resource officer program to ensure year-round support for schools and student populations within public educational institutions.

Furthermore, this administration remains committed to collaborating with the Department of Education to implement and introduce comprehensive mental health and behavioral health programs. These initiatives will involve dedicated staff, including mental health professionals, to work alongside school personnel, students, and their families within public schools. The objective is to proactively address potential behavioral issues, thereby mitigating the risk of future crises. The current incidence of school shootings is unacceptable and preventable.

- **2025 k-12 shooting:** Around 233 incidents which involved a gun fired on a school property, a slight decrease since 2023 where there were 352 shootings incidents, according to the k-12 school shooting data.
- **Victims in 2025:** 148 people injured or killed a decrease from 276 people in 2024 according to k-12drive
- **Collage Shootings:** also saw a decrease in 2025, with up to 64 incidents reported by Omnilert using Evertown data and reports Omnilert.

School safety is not a privilege; it is a fundamental human right. Individuals should be able to enter public spaces, including schools and businesses, without the apprehension of not returning home due to the potential threat of gun violence. The 2nd amendment should not apply to individuals who have an intent to cause serious bodily harm or worse with a weapon. The Second Amendment was established to safeguard individuals against acts of invasion, emulate life-threatening actions, and provide for self-defense in public environments from individuals or groups, including governmental entities. This amendment was not intended to protect those who premeditatively intend to or have caused serious injury or death with a weapon, such as a firearm. Our commitment is to ensure that students, from childhood through higher education, can pursue their studies without fear. My administration will collaborate with the U.S. and State Departments of Education to allocate resources, staffing, and security measures effectively, thereby mitigating the rise of violence.
